


Number of lawyers

There were 26,651 lawyers practising in Victoria as at 30 June 2022. A total of 1,257 new lawyers were admitted to the legal profession in Victoria throughout the financial year.

Diversity

Over 20,500 lawyers reported being born in Australia. The United Kingdom was the most common country of birth for Victorian lawyers born overseas.






Lawyers reported speaking 143 languages other than English, with the most populous other language spoken amongst lawyers being Mandarin.

Practitioners by age and gender

Females now make up 53.3% of the Victorian profession and dominate the age brackets from 21-25 through to 51-55. Beyond this, male lawyers become more numerous. Nine lawyers voluntarily identified as non-binary in FY22.
